KSU insight this month

Student Council updates

We've now held two Student Councils, on 30 October and 4 December. Highlights include:

- Officer Manifesto Objectives were discussed and ratified.
- The policy proposal 'Campus Sexual Wellness and STD Awareness' was discussed, with a decision to approve or reject being deferred to the next meeting.
- Conversations about how to more sensitively engage and empower marginalised students across the Union's activities.



Students Who Work survey

733 students participated in the Students Who Work survey. Analysis is ongoing, but some early indicators highlight:

- 70.3% are currently working part time or full time alongside their studies at Kingston.
- The most common reasons for doing paid work are to pay bills (64.5%), have money to socialise (36.9%), and save for the future (35.5%).
- We asked if paid work affects their academic performance. 51.9% said no, 36.1% said yes (mainly negatively), and 12.0% said yes (mainly positively).

Renters' Rights Act

The Renters' Right Act received Royal Assent on 27 October 2025, and will come fully in force on 1 May 2026. The Act gives stronger rights and greater security for tenants in England.

Some key measures of the Act:

- Abolishment of fixed term tenancies, replaced by periodic tenancy which continues on a monthly basis. Tenants can terminate their tenancies at any time with 2 months' notice.
- Abolishment of Section 21 'no fault' evictions. Landlords will only be able to evict if they have a legal reason called a 'ground', such as rent arrears or antisocial behaviour.
- Prohibition on advance multiple months rent payments. Advance rent payment is capped at 1 month.
- Landlords can only increase rent by issuing Section 13 Rent Increase Notice with 2 months' notice.

These measures also apply for student tenants living in HMO, which means that:

- Students do not have to sign a fixed term tenancy for the whole academic year, and can terminate their tenancies at any time with 2 months' notice.
- Landlords cannot ask international students for multiple months advance rent payment. However, they can insist on international students providing UK guarantors.

KSU recognises that these are significant changes for student tenants, and will ensure that clear guidance & signposting are available on our website so that all students fully understand their rights as tenants. There will also be a 'Know Your Rights' workshop, delivered by Canon in partnership with societies, on 10 December, where students can find out more.

Government Budget 2025

The government announced their annual budget on 26 November. Key items in the budget related to the higher education sector:

- From August 2028, levy on international student fee will be applied: a flat fee of £925 per student (rising with inflation in the following years), with the first 220 students entirely exempted. This means that universities will be unevenly impacted by the levy. Small specialist providers with fewer than 220 international students and providers with higher fees will be less affected. Wonkhe analysis shows that Kingston University will need to pay 5.48% of the international fee income, which amounts to £3,672,250.
- The fund generated from the levy will be used for the reintroduction of maintenance grants. The grants will be means tested: students from households earning at or below £25,000 will get the maximum, and those with household incomes up to £30,000 will get less.
 These grants will only be available for certain subjects aligned with the government's economic priorities and Industrial Strategy.
- Home tuition fee caps will rise to £9,790 in 2026/27, and will cross the psychological barrier to £10,050 in 2027/28.

KSU intends to submit a consultation response on the reintroduction of the maintenance grants.
